





## PARTICIPANT WAIVER RELEASE OF LIABILITY AND ASSUMPTION AND ACKNOWLEDGEMENT OF RISK TRAIL DEGLI EROI 2019

In consideration of being allowed to participate in the TRAIL DEGLI EROI, its related events and activities,

I,.....guardian of the minor, .....

acknowledge that I have carefully read the race rules and that I am aware that the risk of injury from the activities involved in this race is significant. I hereby declare and confirm with my signature that:

- 1. I declare that I have read the rules of the race and agree to abide by them.
- 2. I will not participate unless I am medically able and properly trained, and by my signature, I, for myself and for the minor I'm guardian of, certify that I am medically able to perform this event, I am in good health, I am properly trained. A sports medical doctor has certified my ability to take part to a competition with high cardiovascular effort (B1, B2, B3, B4, B5, B6). I am in possession of this certification. I am aware that the organization will not ask a copy of it.
- 3. I know that running a trail running race is a potentially hazardous activity, which could cause injury or death. I am aware of the length and the characteristics of the race and I have an appropriate training for this typology of event. I am self-sufficient in a wild environment and I am able to manage the problems that can derive from adverse weather conditions (wind, fog, rain, snow, cold).
- 4. I am aware that the role of the organization is support and assistance, but as a competitor I must have the physical abilities and the necessary equipment to face the race course safely and autonomously.
- 5. I am aware of the fact that rescue in inaccessible areas may take time, and I must have adequate equipment and clothing to wait for the rescue in safety.
- 6. I agree to assume full responsibility for any risk, injuries or damages, known or unknown, which I might incur as a result of participating in the event, during the event, on the way to go or come back from the event or while I am where the event takes place.
- 7. I assume all risks associated with running this event, including but no limited to: falls, contact with other participants, the effects of the weather, traffic and the conditions of the trail, all such risks being known and appreciated by me.
- 8. Having read this waiver and knowing these facts and in consideration of your accepting my entry, I, for myself and anyone entitled to act on my behalf and for my heirs and for my executors, waive and release all event organizers, all event sponsors, their representatives and successors, and anyone else connected to the event from all claims or liabilities or legal case of any kind arising out of my participation in this event, even though that liability may arise out of negligence or carelessness on the part of the event organizers.

I have read this release of liability and assumption of risk agreement, fully understand its terms and sign it freely and voluntarily without any inducement.
