Also remember that some points of the regulation that might seem difficult to you arise from the desire to make the administrative tasks usable and fast.

We hope for a triple and mutual satisfaction:

- you will be happy because you will return home with a wonderful memory, probably discovering places that you did not know before.
- we will be happy because our passion has always been that of valorising our mountains.
- nature will be happy because it has been respected.

Read it calmly to understand its content but above all its meaning.

#### **REGULATION 2020**

#### **ARTICLE 1 - GENERAL INFORMATION**

"TRAIL OF HEROES – SKY OF THE HEROES – ULTRA TRAIL OF THE HEROES" are competitive races of racing innature, aimed at the promotion of the territory, its history and the nature that distinguishes it, theand provinces of BELLUNO TREVISO VICENZA and sport in nature valuing the historical resources of food and wine tourism and naturalistic provinces.

THEY ARE NOT MANIFESTATIONS OF ATHLETICS ARE NOT FIDAL MANIFESTATIONS.

While reiterating our esteem and friendship with the manifestations of athletics, we tend, for security reasons, to emphasize that the nature of these events is profoundly different from that of strictly podiistic manifestations.

This is why the regulation might appear to some readers "too restrictive" and "exaggerated" when compared to races of equal distance under the federal aegis.

The Trail Of Heroes Event, for simplicity TdE, which also includes the Sky of Heroes, for simplicity SdE, the Marathon of Heroes, for simplicity MdE and the Ultra Trail of Heroes, for simplicity UTdE, takes place in a potentially hostile environment, in the autumn period, nothing to do with competitions focused solely on athletic gesture.

If, in fact, from the perspective of the FIDAL competition, particularly hostile weather and terrain conditions cause cancellation, in this case they represent one of the natural variables, one of the fundamental elements of the race on which the participants compete in the competitive act. Competitors must relate to this event with the optics and rules of hiking, mountain running and those used to deal with the natural environment independently without underestimating the rules and requirements of the organizers, acting in the interests of the maximum safety of competitors and with knowledge of the cause gained from years of experience in mountaineering.

The event consists of Sky and Trail races in semi-autonomy, organized not-for-profit by APS GS I LUPI TEAM – ADVENTURE RUN volunteers in collaboration with Local Associations, Bodies and People who believe in these values.

The races are affiliated with ITRA. There are no costs or obligations in this regard for athletes.

The races are of a competitive Ludico/Motor character, they require the equipment described in this regulation.

They take place in a single stage.

## **ARTICLE 2 - RANKING AND PREMIES**

There is a general classification with arrival times and posted on the website <a href="www.traildeglieroi.it">www.traildeglieroi.it</a>. The distinct categories in the ranking are "men" and "women".









There are prizes in nature.

Special prizes are awarded to the first arrivals and a reminder of the race attesting to the title of "Finisher" to those who completed the race within the maximum time.

Tributes are also given to all members already at the time of delivery of the bibs (see "QUOTE OF REGISTRATION AND PACCO GARA").

# ARTICLE 3 – TRACK, REFRESHMENT and PARTICATION TO THE CAMPAIGN "I DON'T THROW MY WASTE"

The races are run in semi-autonomy. The semi-autonomy to the "TdE" is defined as the ability to be autonomous between two refreshment points, in terms of their own safety, power and equipment, thus allowing you to be ready to face unexpected problems, for example adverse weather, physical discomfort, small injuries etc.

Water supplies can be made via natural water sources along the route and marked on the map and roadbook.

In order to limit waste production, there are no plastic cups at the rice pot or will be kept to a minimum, so it is mandatory that each competitor has a drinking vessel with them. Upon arrival, each participant can enjoy a full refreshment and a meal offered with the registration.

Please note that all routes have road crossings.

THE ATHLETE MUST COMPLY WITH THE ROAD CODE DURING ROAD CROSSINGS.

#### **ARTICLE 4 - ROUTE TRACKING**

It is advisable to study the technical documentation and the "Road Map" that can be consulted and downloaded from the official website, which will be published within thirty days of the start of the race. Competitors will have to strictly respect the race course marked with Orange flags equipped with reflective and non-reflective webbing, Orange-colored webbing with reflective and non-reflective. Any signs of different colors should be overlooked as they indicate paths unrelated to the TdE and SdE. On the official arrows of the "VdE" is always reported the Logo of the Grappa, other possible arrows of different type must therefore be overlooked. In case you do not meet for several hundred meters the flags markvia, you have to go back in the back until you make sure you are on the correct path. The removal from the official track, in addition to disqualification from the race, will take place at the exclusive risk of the competitor.

# ALL RACES THEY ARE MARKED BY WEBBING, FLAGS and/or ARROWS IN Wood

#### **ARTICLE 5 – REGISTRATIONS**

The opening date for registrations is 1 July 2020. All athletes who are 14 years old with a competitive qualification with requirements specified at the point "MEDICA CERTIFICATION" and who have accepted this regulation and the release at the bottom (the signature of the parent or legal guardian in the case of minors) will be able to register for the competitions.

#### It is also important and necessary:

Be aware of the length and characteristics of the race.









- Be perfectly trained to deal with it.
- Having acquired, before the race, a real personal autonomy in the mountains to be able to better manage the problems arising from adverse weather conditions (wind, fog, rain, cold) in relation to the length of the chosen route.
- Know how to manage the physical or mental problems caused by great fatigue, digestive problems, muscle or joint pains, small wounds etc.
- Be aware that the role of the Organization is not to help a runner manage these conditions that are an integral part of the race experience.

# In the case of the participation of underage athletes, legal guardians are required to be well aware that:

- That the child has the physical and psychological characteristics to face the competition.
- That he has the technical knowledge to deal with it.
- That he can walk the track in conditions that are not in the way or dangerous to the other competitors.

Registration is made via the internet, in the kiosks of the event or in the Authorized Stores according to the procedures listed in the appropriate section.

Please note that you do not need membership to any Federation or Entity.

# ENTRIES WILL CLOSE WHEN THE MAXIMUM NUMBER OF ENTRANTS TO THE RACES IS REACHED OR AT 15/09/2020.

Maximum number of subscribers for SdE 350.

Maximum number of subscribers for TdE 300.

Maximum number of subscribers per UTdE 100.

The registration is to be considered effective and confirmed when all the information requested in the registration form is provided correctly, the payment is made, confirmed and accepted by the organization.









# ARTICLE 6 - EXCHANGES, REFUNDS AND DELEGATIONS

Please note that changes and divestitures of bib are allowed only and only through the online model called "pectoral change" that must be completed in all its parts within 120 hours of the start of the race and sent to the email <a href="info@traildeglieroi.it">info@traildeglieroi.it</a>, subject to a secretariat right of EUR 6. No change, change or divestment is allowed that is not made through the procedure of the above form. The discounted and conventional bibs are transferable only by paying the difference between the reduced price and the price at the time of transfer. Refunds of any kind are not allowed, but competitors can hand over their bib and race package to third parties as described above. No pectoral pick-up or proxy packages are allowed except through an online collection delegation form called "delegation to pick-up." This form must be filled in in all parts within 48 hours of the actual withdrawal. No other forms of delegation are allowed.

### Failure to participate due to incapacity accident certified by specialist doctor or bereavement

- The same conditions as the force major, art 29, without the possibility of handing over the bib to third parties
- The conditions for ordinary divestment mentioned above remain valid

- For cut-price registrations made on any date, the payment must be made by the expiration date of the selected price range. That is, if you sign up for July with a price valid until July 31, the payment must be made by July 31, subject to the cancellation or conversion of the membership to the next price range.
- For all registrations, the payment must be made within 5 days of the registration date. In the absence of notice of payment or request for an extension, after 5 days, it may be cancelled without notice or converted to the current price range or type of bib.

# **ARTICLE 9 - MEDICAL CERTIFICATION**

All those we have received from a sports doctor are admitted to the competition. This eligibility must be valid and specific for activities of high cardiovascular commitment or to have a certificate of fitness of the competitive activity of athletics or other competitive sport with high cardiovascular commitment (canoeing, skiing, football, triathlon, etc.), B1->5 protocols. Adding that the same request is made for foreign athletes. The athlete, participating in the event attests and declares that he has the above requirements and that he has the relevant certification to ensure his safety and safety.









#### ARTICLE 10 - PECTORAL PICKUP AND RACE PACK

To collect the bib, you do not need to show up with the mandatory material. It is not possible to pick up the race package and number on the starting line. The times and location of the race package and bibs are only indicated in the program of the event.

Competitors of the VdE are required to leave a deposit of 40 euros for the GPS tracker. The deposit will be returned at the end of the race on the presentation of the device. The bail must be paid in 20 and 10 euro notes when the bib is withdrawn.

Withdrawals on delegation are accepted only on the completion of the appropriate online form present at the link <a href="https://www.traildeglieroi.it/wp-content/uploads/2020/06/modulo\_delega\_ritiro\_documenti-2020.pdf">https://www.traildeglieroi.it/wp-content/uploads/2020/06/modulo\_delega\_ritiro\_documenti-2020.pdf</a>

The bibs and race pack will not be claimed after the race.

#### **ARTICLE 11 – DEPARTURES**

**SdE PART**: Competitors must show up for the punctualization of the bibs at the timekeepers' stand set up near the starting line, at the Rasai Sports Centre in Seren del Grappa (BL), on 20 September 2020 by 08.45, departing at 09.00. No pectorals are distributed on the starting line.

**PART TdE**: Competitors must show up for the punctualization of the bibs at the timekeepers' stand set up near the starting line, at the Rasai Sports Centre in Seren del Grappa (BL), on 20 September 2020 by 06.45, departure at 07.00. No pectorals are distributed on the starting line.

**PART UTdE**: Competitors must show up for the punctualization of the bibs at the stopwatch stand set up near the starting line, at the Rasai Sports Centre in Seren del Grappa (BL), on 20 September 2020 by 04.45, departure at 05.00. No pectorals are distributed on the starting line.









#### ARTICLE 12 - MAXIMUM TIME GATES HOURS AND WITHDRAWALS

The maximum time to arrive is:

- For "SKY OF HEROES": 7 hours, by 4 p.m. on September 20th.
- For the "TRAIL OF THE HEROES": 11 hours, by 6 p.m. on September 20:
  - o Gate/Withdrawal 1: by 1 p.m. to km 24.5 GRAPPA CIMA Restaurant
  - o Withdrawal 2: Val Dumela
- For the "ULTRA TRAIL OF THE HEROES":
  - o Gate/Withdrawal 1: by noon to km 34.5 Restaurant CIMA GRAPPA
  - Withdrawal 2: Val Dumela

#### **Retreats**

- Any withdrawal must be reported to the operators on the route who will arrange the
  possible transport of the competitor on arrival.
- There is a shuttle service for competitors who want to retire.
- Shuttle stops and schedules are described in the Race Guide and banners at food outlets.
- Shuttles have a passing frequency of less than 90 minutes of waiting, during which you can stay in a protected and tempered area until the passing time approaches.
- There will be a "broom service" that will run along the track following the last competitor in the race, so as to help the retirees and prevent any injured people from remaining unassisted.

#### **ARTICLE 13 - SECURITY AND CONTROL**

On the route there are organization workers, volunteers of the Civil Protection and Alpine Rescue, in constant contact with the base. There is an ambulance in the arrival area with a doctor on board and paramedics, ready to intervene. At the top of Grappa there is an ambulance with paramedics. There are other ambulances along the way.

Control points are set up along the track, where organization workers monitor the passage of athletes. It is mandatory to pass near the checkpoints going to the pass, without running and with the bib clearly visible placed on the chest or backpack or leg.

You should make sure that you have registered correctly because disqualification is applied if you do not register or fail to pass to a checkpoint.

Any runner injured or in distress can ask for the help of the Organization:

- showing up at an official checkpoint
- calling an organization number
- asking another runner to alert the rescuers

It is necessary and obligatory to provide assistance to all people in need and to notify the emergency services if necessary. If a competitor has wasted time to rescue another injured or distressed competitor, they may require the Race Jury to reduce the time spent on the official leaderboard.

# **ARTICLE 14 - RACE EQUIPMENT**

The TdE, SdE and VdE is an environment race that can be hostile with challenging and exposed traits. The winter period and the geographical area make the weather extremely variable and unpredictable conditions offering participants conditions that can range from the near-spring sun and dry terrain, to wind gusts of 100 km/h, sub-zero temperatures and ice.

#### RECOMMENDED MATERIAL

- Front stack or flashlight with batteries installed and charged. (Even those who plan to complete the race before it gets dark are required to have this material with them, as any unforeseen events such as accidents, course mistakes or otherwise, could prolong the expected arrival time. SdE participants are explicitly required to have a front lamp or emergency electric light other than the smartphone)
- At least 350ml of liquids
- Double thermal layer or thermal padded jacket (i.e.: long sleeves and windproof and windproof shell or pose padded jacket and windproof jacket for those wearing under short sleeves)
- Long trousers or combination of shorts and leggings that cover the whole leg in case of need
- Thermal blanket (emergency isothermal sheet)
- Emergency whistle
- Gloves
- Cap
- Route roadbook (present behind bib)
- Mobile phone with registered organization numbers and always turned on
- **Eco-energy** or drinking vessel: there are no glasses at the rice!

It is recommended, for greater well-being, to start with the following material:

- Long sleeve sweater or extra warm garment
- Scarf, balaclava or windproof buff.
- Foldingsticks.









#### **ARTICLE - 15 WEATHER**

Given the extreme climate and meteorological variability, the organization will publish two weather reports on the website www.traildeglieroi.it to the "news" section with the following purposes:

**Bulletin 1:** 5 days from the race, to inform about the conditions of the route and the weather forecast.

**Bulletin 2**: 12 hours from departure with the latest updates and result of the last relief on the route. In conjunction with the Bulletins, additions or variations may be made to the suggested equipment. In the case of extreme weather phenomena, landslides or events that make the path impractical, last-minute variations will be possible. Any changes will be communicated clearly and as quickly as possible to the participants also through workers on the course in case the race is in progress. In these cases, there is no provision for compensation to competitors. There is no suspension of the race unless the Red Weather Alert or at the disposal of the Prefecture and/or Municipality: the date and geographical area are in itself indicators of a strong possibility of bad weather, which is considered as one of the fundamental components sought by the athlete in the competition.

#### **PENTHOUSE 16 – ENVIRONMENT**

Running takes place in natural ecosystems. Competitors must behave environmentally friendly, in particular avoiding dispersal, flower picking and harassing wildlife. **Disqualification in the event of voluntary littering along the route.** 

It will be verified that any GEL, bars and consumable wrapped material are marked with the competitor's bib number. This is only in order to identify any litter left over the route. During the race it will be possible to re-integrate the food stocks to the Ristori, Life Points, at the discretion of the competitor, after marking all the inshorts.

Each competitor, as indicated in the recommended material, is required to have a personal container for liquids.











#### **ARTICLE 17 - SACRED CROSSING CIMA GRAPPA**

THE RACE TAKES PLACE THROUGH THE SHRINE OF TOP GRAPPA.

THE ATHLETE IS HELD AT HIS CROSSING IN RESPECTFUL SILENCE, AS REQUIRED BY THE PLACE, AND WITHOUT HASTE.

FAILURE TO COMPLY WITH THIS PROVISION WILL LEAD TO DISQUALIFICATION.

Please note that all routes have road crossings.

THE ATHLETE MUST COMPLY WITH THE ROAD CODE DURING ROAD CROSSINGS.

#### **ARTICLE 18 - USE SHOWERS AND WARDROBE**

Competitors will be able to leave a personal bag, of maximum size 40x60x20, with full gearbox, which must be marked on the handle with its own bib number. The bag can only be left in the wardrobe of the TdE Village on the morning of departure.

#### In addition

- There is no response to the loss or damage of the bags.
- We do not accept bags with specifications other than those provided by the organization.
- A shower service is planned when the race arrives.
- There is no response to items left in the locker room as for hygiene and safety reasons at the end of the race they are eliminated.

## **ARTICLE 19 - STICKS AND OTHER AIDS**

It is allowed to use the sticks on the condition that they must be held from the moment of departure until arrival.

It is forbidden to have them brought or abandoned along the route. The use of non-transport vehicles other than those provided in the regulation is prohibited.









#### **ARTICOLO 20 - NAVETTE**

- Shuttles are free for subscribers
- The shuttle service for the retreats is free

#### ARTICOLO 21 - DICHIARAZIONE DI RESPONSABILITA'

The voluntary registration and subsequent participation in the race indicate the full unreserved acceptance of this regulation and the ethics of the race, available on <a href="www.traildeglieroi.it">www.traildeglieroi.it</a>. With the registration, the participant exempts the organizers from any liability, both civil and criminal, for damages to persons and/or things caused by him or to him, before and after the race and waives any claim for compensation.

The Release must be completed, signed and delivered before the delivery of the bib, which will take place only after the receipt of the aforementioned.

# **ARTICLE 22 - PENALTY AND DISQUALIFICATIONS**

The organization's staff on the course are allowed to check the compliance with the regulations by the runners and communicate to the race jury the infringements found.

The race jury applies the penalties according to the table below.

Time penalties are applied immediately at the end of the race or in the following days with increased time reported on the official leaderboard.

- Disrespect of silence during the crossing of the Sacrario di Cima Grappa: disqualification
- Voluntary abandonment of waste: disqualification
- Starting from a checkpoint beyond the limit time: disqualification
- Cutting a section of course above 200m: disqualification
- Failure to switch to a checkpoint: disqualification
- Refusal to be checked: disqualification
- Cheating: use of an unauthorized means of transport, sharing or exchanging bibs, marking messed with other people's numbers: disqualification and ban for life
- Insults and threats to volunteers or employees of the Organization: disqualification and ban for
- Dispute of the rules or disrespect for the race staff: disqualification
- There is a 30-minute penalty if you consume, transport or use bars, supplements or gels that do not have the number of bibs of the user









### **ARTICLE 23 - COMPLAINTS AND DISPUTES**

- Only written claims are accepted within 30 minutes of the last competitor's arrival time, with a deposit of €300.00.
- The official version of the regulation is the one written in italian language.
- Disputes or interpretative doubts must be resolved by faithful to the official version.
- All irregularity complaints submitted within 30 minutes of the last competitor's arrival and related:
  - o Clear and unequivocal photo documentation
  - Testimony of three people (to be verified with the race data and surveys in our possession)
  - If a complaint of irregularities is deemed to be justified we will proceed immediately to apply the sanctions as per regulation with the guarantee of the complete anonymity of the complainant.

#### **ARTICLE 24 - JURY**

The jury consists of:

- Race Director
- Responsible Security Coordinator
- Head of the medical team
- Supervisors

All competent persons appointed by the chairman of the committee Organizzatore.La jury is allowed to deliberate in a time compatible with the obligations of the race on all quarrels or disqualifications that occurred during the race. The decisions taken are without appeal.

#### **ARTICLE 25 - INSURANCE**

The organization signs up to TERZI liability insurance throughout the trial period. Participation takes place under the full responsibility of the competitors, who waive any appeal against the organizers in the event of damage and additional consequences that arise as a result of the race.

At the time of the withdrawal of the race bib the competitor must sign a disclaimer.

#### **ARTICLE 26 - IMAGE RIGHTS**

With the registration, the competitors authorize the organization to use free, without territorial and time limits, still and moving images that portray them on the occasion of the participation in the Event called Trail of Heroes, which includes the Sky races of Heroes, Trail of Heroes, Journey of Heroes.









#### **ARTICLE 27 – UPDATES**

The Organization is committed to publishing on the website <a href="www.traildeglieroi.it">www.traildeglieroi.it</a> "news" section of any updates on the course and race conditions.

#### ARTICOLO 28 - ROAD BOOK

Starting on September 1, competitors will have a "ROAD BOOK" available in digital format available for download.

The above guide explains in detail the race course by reiterating its concepts and expanding it with the latest updates.

This guide is an official document to complement and extend the aforementioned regulation. It is well known that the information reported in the Road Book of the year in which the race takes place and in the profiles published in it **should be considered as definitive and replace any other information online,** except last hour updates sent via email and published in the "news" section with the explicit wording: "Replaces the information present in the Road Book"

#### ARTICLE 29 – CANCEL OR POSTPONE RACE

- The race will be held in all weather conditions that allow it to take place safely.
- If the conditions are unfavourable, alternative routes and escape routes are provided so that they can be carried out.
- Cancellation by force greater and/or if it has not happened to provide the service We expect a refund policy to protect the competitor to the maximum, taking into account that the TRAIL OF THE HEROES is an event that requires to incur high costs and a very complex preparation process. We have made the equivalent of a full refund, net of the living costs incurred and cash flows.

**For cancellations 15 days or less** from the event, we expect to pay **120%** of the share in the following ways:

**45 days 65%:** Cancellation for reasons of force of force and/or after being unable to provide the **service** more than 45 days after the event we offer two options

- 1. Reimbursement of 30% of the share 35% off the next year's edition.
- 2. Transfer that can also be transferred once to third parties on the next year's edition, or not transferred to third parties with a validity of two years.

**30 days 80%:** Cancellation for reasons of force of major strength **and/or after being unable** to provide the service more than 30 days after the event we offer two options:

- 1. Reimbursement of 30% of the share 50% off the next year's edition.
- 2. Transfer that can also be transferred once to third parties on the next year's edition, or not transferred to third parties with a validity of two years.









**15 days 120%:** Cancellation for reasons of force of major force **and/or the impossibility of providing the benefit** for more than 15 days:

1. 90% discount not sold on the next year's edition and 30% off not sold on that of the following year.

Terms of use discounts, transfers and refunds:

- 1. The recognized discount is equal to the percentage indicated relative to the share actually paid by the competitor.
- 2. The discount cannot be combined with other discounts or promotions.
- 3. Any options must be confirmed through the reserved area on the membership id platform no later than 60 days from the date of cancellation of the event.
- 4. In the event of a transfer of registration to the following year, it must be confirmed again after the opening of registrations and no later than 90 days from the date of the race. If there is no confirmation, the transfer for the current year expires with no possibility of reimbursement. However, it remains valid, however, only if expected, the transfer to the following year.

Please note that all routes have road crossings.
